### Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments and federal and state health agencies worldwide recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

The Hungarian American Athletic Club and its affiliated groups (HAAC) has put in place preventive measures to reduce the spread of COVID-19; however, the HAAC cannot guarantee that you or your child(ren) will not become infected with COVID-19 and the HSA cannot prevent you or your child(ren) from becoming exposed to, contracting, or spreading COVID-19 while attending and participating in HAAC activities. Further, attending activities on the HAAC premises could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and on behalf of myself, my child(ren), my and spouse/co-parent of child(ren) voluntarily assume the risk that my child(ren) and I, and any member of my family, may be exposed to or infected by COVID-19 by attending activities on HAAC premises and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 while on HAAC premises may result from the actions, omissions, or negligence of myself and others, including, but not limited to, HAAC representatives, volunteers, program participants and their families and/or any other individual who may be present upon HAAC property or in attendance at any HAAC activity.

I voluntarily agree to assume, on behalf of myself, my child(ren), and my spouse/co-parent of child(ren) all risks and accept sole responsibility for any injury to my child(ren), myself and any member of my family, (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I, my child(ren) and/or members of my family may experience or incur in connection with my child(ren)'s attendance in activities or participation in HAAC programming.

I agree to comply with all policies and rules for HAAC activities, including but not limited to all policies, guidelines, signage, and instructions.

I represent, warrant, and agree to the following:

- I understand the symptoms of COVID-19 as described by the World Health Organization – fever, dry cough, fatigue, body/muscle aches or lack of taste or smell.
- I affirm that neither I, my minor child(ren), nor any member of my household, currently has or has experienced the aforementioned symptoms within the past 14 days. Furthermore, I will immediately inform HAAC and discontinue participation in all HAAC activities if I, my minor child(ren), or any member of my household develops any of the aforementioned symptoms.

- I affirm that neither I, my minor child(ren), nor any member of my household, has been diagnosed with COVID-19 within the past 30 days. Furthermore, I will immediately inform HAAC and discontinue participation in HAAC activities if I, my minor child(ren), or any member of my household, is diagnosed with COVID-19.
- I affirm that neither I, my minor child(ren), nor any member of my household, has knowingly been exposed to anyone diagnosed with COVID-19 within the past 30 days. Furthermore, I will immediately inform HAAC and discontinue all HAAC activities if I, my minor child(ren), or any member of my household, is knowingly exposed to anyone diagnosed with COVID-19.
- I affirm that neither I, my minor child(ren), nor any member of my household, has traveled outside of the country or to any city considered to be a "hot spot" for COVID-19 infections within the past 30 days. Furthermore, I will immediately inform the HAAC and discontinue all HAAC activities once I, my minor child(ren), or any member of my household, returns from traveling outside of the country or to any city considered to be a "hot spot" for COVID-19 infections.
- I understand that the HAAC cannot be held liable by me for any exposure to the COVID-19 virus caused by any misinformation on this form or the health history provided by or on behalf of my minor child(ren).
- I voluntarily agree to assume, on behalf of myself, my child(ren), and my spouse/co-parent of child(ren) all risks and accept sole responsibility for any injury to my child(ren), myself and any member of my family, (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I, my child(ren) and/or members of my family may experience or incur in connection with my child(ren)'s attendance in activities or participation in HAAC programming.
- I have read and understood all procedures put in place by the HAAC and its instrumentalities to prevent the spread of COVID-19.
